SCHOOL & HOSTEL RULES

1. The learner will attend school every day.
(In case of absence due to illness or other legitimate reasons, a letter must be received by the class teacher at the first possible opportunity, giving an explanation for the absence. In case of illness of MORE THAN ONE DAY, A DOCTOR'S CERTIFICATE should accompany the letter).
2. The learner will arrive for classes or other activities punctually.
3. The learner will be correctly and neatly dressed in the official school and sport wear.
4. The learner is aware of the spirit of mutual respect prevailing at the school/hostel, and will honour it.
5. The learner will do his/her homework and other tasks given to him/her.
6. The learner will not use a cell phone at school.

If a learner makes him / herself guilty of the breaking of the above mentioned rules or of any of the following; the learner may be punished according to the seriousness of the offence, whereby suspension or expulsion are included:

- a) being late/ignoring bells
- b) disobedience
- c) wearing untidy school uniform/incomplete/hitchhiking in uniform
- d) messing/littering
- e) Not attending meals, activities
- f) untidyness
- g) Bad language/fighting and assault
- h) Illegal use of electrical appliances, dangerous weapons
- i) Caressing
- j) Disrespecting authority, prefects
- k) Smoking/spectator to/alcohol and drug abuse
- l) using cell phone in class/study
- m) Disruption
- n) Dishonesty
- o) indecent clothing, immoral behavior
- p) theft, criminal offences, bullying(physical and emotional)
- q) leaving school/hostel grounds without permission
- r) Vandalism
- s) pornography
- t) gangsterism

UNDERTAKING BY PARENT/GUARDIAN:

1. I, as parent/guardian take note of the Code of Conduct, and acknowledge the right of the school/hostel to implement it.
2. I undertake to study the Code of Conduct carefully and to abide by it.
3. Parents/guardians will pay all a school/hostel fees in advance.

(It is the responsibility of the parent/guardian to make arrangements with the financial official as to how payment will take place as well as any arrangements concerning exemption or exemption of fees)

4. The parent/guardian will replace or make good any property of the school/hostel which is lost, destroyed or damaged by the learner.
 5. I hereby authorize the principal or his designates to act on my behalf at his own discretion (in loco parents) in urgent cases e.g. illness, etc
 6. With regard to punishment, the principal or his designate may act in loco parentis and may administer punishment.
